Service Information

Our fees are set out as a range depending on the service-level, investment, and assistance required by the clients. Typically, Vialto Partners would provide the following service for the fees set out above:

- Completing a comprehensive assessment and review of your individual circumstances; including immigration history, identified risks, dependents (if applicable), and potential alternative immigration options available.
- Providing full written advice on legal requirements, next steps, and provisional timelines.
- Assisting with the end-to-end process of the application.
- Advising on English language and Life in the UK tests.
- Ensuring all requirements are satisfied before assisting with submitting the application, clearly stating the likelihood of approval, and advising on further evidence which can be submitted, where all the requirements may not be met.
- Contact the Home Office to enquire on potential delays or questions they may have.
- Reviewing decision letters and visas to ensure they have been issued correctly and advising on the completion of the cases.
